President's Message

The Judiciary should be the most unassuming of the three branches of our government. I think I can speak for all our Frederick County Judges when I state that we all would like to decide our cases in the best way that we can and quietly move on to the next case. No judge goes looking for publicity if we can avoid it. The United States Supreme Court, however, does not have that luxury. Last week's earth-shattering opinions relating to two of the most controversial social issues in the United States, abortions and guns, will reverberate for decades to come. Many Americans have strong feelings on either side of these issues, and the Supreme Court and its justices are the object of ire or adulation depending on their viewpoint. As lawyers we know that the courts don't create laws; the legislature does. We also understand the role of the courts. The majority of non-lawyers, however, do not necessarily comprehend that.



I recently moved into a new house and was happy to find a former Sheriff's Deputy whom I have known for 25+ years living a few doors down from me. We judges do worry about security in this day and age. Just a few weeks ago a judge in Wisconsin was murdered by a man he had sentenced to prison years ago. My best friend from college is a judge in the Superior Court for Bergen County, N.J., and as a former Assistant United States Attorney he is personally acquainted with U.S. District Court Judge Esther Salas. Judge Salas' son was murdered and her husband shot in their family home in 2020 by an attorney who was angry with her rulings. Frederick County is fortunate to have such close-knit legal family as I view our Bar Association. I am sure that all our members realize our judges are real people from our close interactions at bar functions and other places. When you see me outside of the courthouse, please say hi and call me "Dino." I prefer that you not call me "Judge Flores" in public. It's too formal from one lawyer to another outside of the work environment, and I never know who may be listening. There is no luncheon in July, but I hope to see everyone at the Key's Game on July 8 and at our August luncheon on August 2.

MSBA Legal Summit & Annual Meeting

This year was a very different year for the MSBA Legal Summit and Annual Meeting. It was the first year back to an in-person meeting since COVID took over our lives, but it was also the first year at the Ocean City Convention Center. The number of Frederick lawyers attending was lower and we had some notable absences, but the ones who traveled to Ocean City enjoyed being with other lawyers, learning, networking and playing just a little.



Attendees could watch several gubernatorial candidates speak – both in person and virtually. The Republican primary governor forum on May 31 was digital and featured only Kelly Schulz as the other Republican candidates declined to take part. Dan Abrams, Ari Melber and Brandon Etheridge were the keynote speakers at the Convention Center on Wednesday, June 1. Frederick lawyers were in attendance at the opening happy hour with a band and great appetizers (some people were stalking the raspberry brie in phyllo dough). The specialty bar hospitality suite opened at the Double Tree that night.

Classes began in earnest June 2, with offerings from wellness to cyber security to substantive law. The Hon. Lynne Battaglia, et al. led “Are you Smarter than a Law Clerk Redux?” mid-day and before the Seacrets happy hour sponsored by the Worcester County Bar Association and Vallit. Seacrets saw lawyers and judges mingling with their feet in the sand with beautiful warm breezy weather. A storm then moved in just as the President’s Reception and 125th Anniversary celebration started later that evening. The weather did not impact the attendees’ enjoyment. The night capped off with “Late Night” with local bar associations hosting a hospitality get-together and silent disco.

Traveling between locales for MSBA conference events made the event feel less cohesive. Members were disappointed by the lack of interaction between classes and with vendors.
