President's Message

Summer is upon us, but events keep coming with the Bar Association of Frederick County: Tuesday, the 6th brings our next Bar Luncheon; Friday the 16th brings the annual baseball game at Nymeo Field at Harry Grove Stadium with before game picnic hosted by McNees Wallace & Nurick LLC; and the Young Lawyers' Section's Summer Bash at the Fourth Dimension will be on June 29.

Thank you to everyone that assisted with and attended the Dinner with Judges and Magistrates on May 18. It was great to have this event return after four years. In addition to enjoying the company of fellow members of the Bench and Bar several members of the Bar Association were recognized for their dedication: Janice Rockwell received the James McSherry Memorial Award, William Poffenbarger received the W. Jerome Offutt Award, and Blaine Hoffman received the Gordon M. Cooley Pro Bono Service Award, posthumously.

At the time of its founding in 1923, the members of the Bar Association drafted and adopted a Constitution and Code of Ethics. By 1929 a bound copy of the Constitution, By-Laws, Minimum Fee Schedule, and Canons of Ethics, became available. Article II of the Constitution was entitled, "Object," and read: "The Association was formed to advance the science of jurisprudence, to promote reform in the law, to facilitate the administration of justice, to uphold the standard of integrity, honor and courtesy in the legal profession, to encourage legal education and to cultivate a spirit of cordiality and brotherhood among the members of the Bar." These ideas are good to keep in mind as we go about our daily work.

Any member of the legal profession of Frederick County wanting to join the Bar Association could do so prior to March 31, 1923 by simply signing the Constitution and Code of Ethics and paying the admission fee of One Dollar. Following March 31, 1923, the process we still employ today was followed: nominations are made to the President and reported to the Executive Committee, which examines the nomination and makes a recommendation to the larger Association at the next regular meeting. The members of the Association then vote on the nomination.

I hope everyone has a great Summer – and do not forget to mark your calendars for August 24th for the annual Golf Tournament at Musket Ridge Golf Club and the Summer Picnic at the Lewistown Social Club.




MSBA Connections Event in Frederick

We look forward to continuing this tradition in the Fall of 2024. Keep an eye out and save the date!







BAFC Annual Awards

With the return of the annual Judges Dinner it only seemed fitting that we used the event to return to the in-person presentation of the BAFC Annual Awards. Read below to find out more about the members recognized.

Magistrate Julie Minner opened the award presentation by presenting the **W. Jerome Offutt Award** to **Bill Poffenbarger**. This award recognizes a member who has contributed to the advancement of professionalism and civility in the practice of law in Frederick County. "Poff", as he is known, has maintained a criminal law practice in Frederick for over 30 years. A practice like his, and the respect he enjoys, does not happen without maintaining the respect of the people he represents, the court, prosecutors, law enforcement and other attorneys. He unfailingly reciprocates respect for all involved in the process and has distinguished himself over these many years as knowing the law cold. He is not stingy about sharing his knowledge and answering everyone's questions; he shares his knowledge with



anyone who asks. Some fun personal facts that Magistrate Minner shared with the audience: getting beat up pretty badly by a bull has not kept him from coming to court, he once caught a bat with his bare hands on the third floor of the courthouse and walked it outside and released it, and he has never once worn a winter coat to court.

April Dixon presented the **James McSherry Memorial Award** to **Janice Rockwell**. This award recognizes a member who has demonstrated outstanding service to the Bar Association of Frederick County. Janice's seemingly endless energy and desire to bring entertainment to events gave new life to the Holiday Party in 2018 by introducing the karaoke contest. Janice served as BAFC President during the height of the pandemic. She managed to think outside the box in continuing to bring our membership together. Despite the inability to meet in person, she kept a sense of joy and inclusivity in the face of the pandemic. The virtual holiday party and the community service gleaning activity at First Fruit Farms are just two examples of the many engaging events she helped coordinate during the pandemic. Janice's service to the Bar did not end after her tenure on the executive committee. She continues to prioritize the bar association by attending monthly luncheons, networking and educational events, including the Young Lawyer events, and serving on committees.



The award presentations concluded with Jennifer Dayton presenting the Gordon M. Cooley Pro Bono Service Award to Blaine Hoffmann, posthumously. Jennifer was honored to present the award to Blaine's parents, Ken and Anne Hoffmann, who were in attendance. In her presentation, Jennifer shared the memory of when her friend "Baltimore Blaine" told her he was thinking of moving to Frederick. Growing up in Frederick, Jennifer shared that she decided this was exactly what her hometown needed. Blaine began his work as Legal Director with Heartly House in April of 2007. His work went beyond protective orders and custody hearings. Blaine always took a holistic approach in assisting clients, making sure they had





what they needed to be safe and thriving even after their work with Heartly House was concluded. Blaine was respected by the Frederick Judiciary, courthouse staff, and Bar Association. As one nominee stated through legal services to survivors and their children, Blaine dedicated his life to the betterment of his community.

BAFC PRACTITIONERS OF THE BAR: Mary Ann Stepler

An occasional series of profiles of former Frederick County attorneys By: Tom Slater, BAFC Historian

I first heard the name Mary Ann Stepler in 1980 when I was serving as an intern in Fred Bower's office on Church Street. I started teaching in Frederick County in 1966 and, after about ten years of teaching, I decided to go to law school. Fred and I had both been elected to the Democratic State Central Committee in 1974 and 1978 (he was first elected in 1970) and had become good friends, and I discovered that I could earn three credits at the University of Baltimore by interning in a lawyer's office. Fred graciously allowed me to intern for him (at no pay) during the summer of 1980. Fred was also president of the Bar Association of Frederick County at that time and District Court Judge William Wenner had just been appointed to the Circuit Court, leaving a vacancy in the District Court. William Wenner had been appointed to succeed Byron Thompson on the District Court. As was customary then and continues to be the practice, a survey was made of Frederick County attorneys to determine whom they thought should be appointed to fill the vacancy. Fred asked me to tabulate the results of the survey. William Haugh came out on top, closely followed by Mary Ann Stepler, far ahead of others including Mary Storm and Cleopatra Campbell. Fred sent me over to the courthouse (now City Hall) to meet with the lawyers on the local judicial selection committee to report to them the results of the survey. My recollection is that they were some of the "old bulls" of the bar. I don't clearly remember all who were on the committee, but Ed Nikirk, Manny Weinberg, and Jerry Offutt come to mind. Well, they really did not like that a school teacher had tabulated the results and insisted that the surveys be sent to the accounting firm associated with Donald Linton so that the results could be tabulated by a CPA. Of course Linton's firm sent to the BAFC a hefty bill for their work and, no surprise, the results were the same as my calculations. I discovered during that process that Mary Ann Stepler was well-respected by her peers. She was subsequently appointed by Governor Hughes to the District Court. It was time. She was the first female to be appointed to the bench west of Montgomery County.

Mary Ann was born in York, Pennsylvania, attended Waynesboro, Pennsylvania public schools, and received a BA degree from American University In 1967. When she was twenty years old, she married Howard Stepler, a lawyer in Frederick County. Howard and Mary Ann were the parents of two boys, Howard III and Robert. In 1974, she graduated from the University of Baltimore School of Law, cum laude. For the seven years after graduating from American University and before being admitted to the bar, Mary Ann worked as a reporter for the Morning Herald in Hagerstown and the Montgomery Sentinel. After she was admitted to the bar, she started the practice of law with Howard, and Stepler and Stepler was formed. She discovered that she enjoyed and was proficient at litigation. Apparently, State's Attorney Robert Rothenhoefer appreciated her litigation skills because he hired her to be a part-time Assistant State's Attorney for Frederick County in 1974. She eventually became the Chief Prosecuting Attorney for the State's Attorney's office in 1977 and served in that capacity until appointed to the District Court in 1980.

Her time on the District Court was not without controversy. The District Court was created by an amendment to the Maryland Constitution and came into existence on July 5, 1971. Governor Mandel appointed the first two judges to serve on the District Court in Frederick County, Byron W. Thompson and Stanley Y. Bennett. Thompson was a seasoned attorney who had previously been an appointed trial magistrate in Frederick County. Bennett, like Thompson, had also been a trial magistrate. He had been appointed as a trial magistrate in 1960, the same year he was admitted to the bar when he was 25 years old. That appointment and his appointment to the District Court in 1971 raised some eyebrows in the legal community, and it was thought that the appointments had much to do with the fact that his father, Alton Y. Bennett, also a lawyer and at one time a trial magistrate, was the undisputed leader of the Democratic Party in Frederick County, with influence in the Maryland political community.

When District Court Judge Wenner was appointed to the Circuit Court in 1980, there was some friction between Wenner and his fellow District Court Judge Bennett. Bennett had sought the Circuit Court appointment and Wenner had indicated that he would defer to Bennett as to the appointment, but when Bennett did not get the recommendation of the Trial Courts Judicial Selection Committee, Wenner put his name in for the position and was appointed. Subsequently in 1982, when Wenner ran for election to a 15 year term on the Circuit Court, Bennett filed in both party primaries to run against Wenner. A hotly-contested primary election battle ensued.

In April of 1982, Judge Stepler found Randy Marion Demaris guilty of a traffic offense. According to the Maryland Court of Appeals (In re Formal Inquiry Concerning Judge Stanley Y. Bennett, Misc. Judicial Disabilities No. 1, Sept. Term 1984 Court of Appeals of Maryland November 26, 1984) shortly after Demaris was found guilty, Marion "Pus" Rice asked Judge Bennett to look into a traffic conviction that his grandson (Randy Marion Demaris) had incurred. "Pus" Rice was known as a strong supporter of Alton Bennett and his son, Stanley. In June 1982, Judge Stepler was informed that an Exception Report to her disposition in the Demaris case had been filed with her signature on it despite the fact that she had not filed nor signed such a report. Judge Stepler reported this event, and eventually a grand jury was called into special session. The Attorney Grievance Commission conducted an investigation, and Judge Bennett was removed from the bench, and he lost his license to practice law. Before all of this controversy was concluded but after some rumors were circulating, Wenner handily defeated Bennett in both the Republican 4,116 to 2,273) and Democratic (6,695 to 4,177) primary elections.

In 1986 Judge Stepler again replaced Judge Wenner when he was appointed to the Court of Special Appeals and she was appointed by Governor Hughes to the Circuit Court for Frederick County. She served on the Circuit Court until she retired on September 30, 2003. In 1988 Jim Respess challenged her election to a 15-year term on the Circuit Court but Judge Stepler defeated Respess in the Republican primary (5,373 to 1,170) and the Democratic primary (8,113 to 1,388)

In order to understand more about Judge Stepler, I have talked to some of her closest friends and associates, who shall remain nameless. Universally, they remember her for her kindness, her love of jewelry, her skill as a trial attorney, her ability to settle cases, and her deficiencies behind the wheel of a car. Those who worked with her remember her kindness. When hearing that some young children did not have many toys to play with, she brought some of her children's old toys for the parent to have. When she sentenced convicted criminals to long sentences she did it with such kindness in her voice that sometimes they thanked her. It was said that her husband, Howard, when she told him that she was putting her name in to be a judge, objected because he wanted her to handle the firm's trial work. She loved her jewelry, especially glimmering bracelets and was always impeccably dressed. When she was a trial attorney, she remarked that she sometimes wore shiny jewelry to get the attention of the jury. One time, her boys buried most of her jewelry when they were playing pirates and she was in a panic. When she was in the Circuit Court, "steplerizing" became a noun. To be steplerized was to be strongly encouraged to settle a case. I was in the Circuit Court judge's chambers one time when I overheard Judge Stepler offer to an assistant State's Attorney and a public

defender to decide the disposition of a juvenile matter by drawing straws. Judge Dwyer also overhead the conversation and said "Mary Ann you can't do that," and she said "Oh, I was just kidding." But was she? During one of the MSBA annual meetings in Ocean City, Mary Ann decided to sign up for the members' golf tournament although she had never played golf before. I was in a foursome with Jan Ambrose, Judge Stepler, and my teenage son, Mark. Stepler was "dressed to the nines" in a brand new golf outfit and had brand-new golf equipment. As Jan said many years later, "It was a hoot!" I doubt if Mary Ann ever played golf again. Judge Stepler was a nightowl and often stayed up until early morning, which consequently often caused her to be sleepy in the afternoon. Occasionally she would nod off while on the bench in the afternoon. She instructed her clerks that if they ever noticed her nodding off, they should bring her a soda with lots of caffeine. There are stories about her driving ability, or lack thereof. She apparently had trouble with speed, curves and paying attention to the road while talking to her passengers. Back when the District Court held remote hearings in Thurmont and Brunswick, Judge Stepler would insist on driving her clerks and bailiff's to either Brunswick or Thurmont and the clerks and bailiffs would fight one another to see who could get the back seat so they would not have to ride up front with Judge Stepler because it was too scary. Unbeknownst to a lot of lawyers, Judge Stepler had lots of out-ofcourt interests, including collecting vintage buttons, glassware, antiques, pop-up books and "Alice in Wonderland" books. She also was an accomplished musician and artist who played violin with the Greenspring Valley Orchestra from Stevenson University. In addition, she was known for her great sense of humor. Mary Ann Stepler was a role model for young female attorneys in Frederick County and many attorneys, male and female, have fond memories of her. She died on December 11, 2014 at the age of 72. Howard Stepler predeceased her on October 9, 2006.
