BAFC PRACTITIONERS OF THE BAR: Five Generations of Weinbergs at the Bar

An occasional series of profiles of former Frederick County attorneys By: Tom Slater, BAFC Historian

In 1872 U.S. Secretary of State Hamilton Fish signed a document saying "the undersigned Secretary of State of the United States of America hereby request all whom it may concern to permit safely and freely to pass Samuel Weinberg, a Citizen of the United States, and in case of need to give him all lawful aid and protection." This document adorns the wall of Frederick lawyer Cody Weinberg. Family lore says that Samuel Weinberg, Cody's great, great grandfather was given the pass so he could travel into the reconstructed American South on Union business without being shot on site as a carpetbagger.

Samuel's son, Leo Weinberg, Cody's great, great uncle, was one of the giants of the bar in Frederick County in the first half of the nineteenth century. John Ashbury includes Leo in his book "Frederick County Characters – Innovators, Pioneers & Patriots of Western Maryland" which I summarize in this article. He was born into one of Frederick's leading Jewish families and was known for his eloquence. A lover of English language and literature, he had what was believed to be a photographic memory. He was one of nine children, one of whom, (Isaac) was Cody's great, great grandfather. Graduating from Boys High School in 1903, he received a law degree in 1906 and was admitted to the bar in 1907. He soon formed a partnership with Frank L. Stoner. It was said that whenever Leo argued a case before the Court of Appeals, lawyers in Frederick would close their offices and travel to Annapolis just to hear his eloquent appellate arguments. Locally, citizens of Frederick were known to gather on the grounds of the courthouse (now Frederick City Hall) to get in line to join the gallery to hear cases that he argued in the Circuit Court. His most notable client was Emory L. Coblentz, who faced multiple criminal and civil charges related to the collapse of the Central Trust Bank and closure of its fourteen offices. Coblentz was acquitted or found not liable in every case.

Chris Heidenrich, in "Frederick Local and National Crossroads" and John Ashbury both credit Leo Weinberg with the establishment of the first synagogue in Frederick in the former Elks Lodge building at 20 W. Second Street, next door to Leo's home. At Weinberg's encouragement a local chapter of the National Council of Jewish Women was formed in 1921, and in 1923 Leo and his wife, Rae, donated the Elks building for a synagogue and, after the building was renovated, Beth Sholom was dedicated to Leo's parents Samuel and Amelia on September 2, 1923.

Leo's life ended too soon on September 17, 1942. He wrote his own obituary which read, in part, "Thus death has closed a colorful, contradictory career. He was indeed intolerant of opposition, yet he identified himself with a profession in which he was bound to be opposed. He advocated law and the social standards and conventions arising out of them. Yet he violated them. He knew all of the thrills of ecstasy and felt all of the pangs of misery. He was either at the apex of glory or in the abyss of despair."

Leo's nephew, Manuel, followed Leo's path, graduating from Washington and Lee University in 1931 along with future U.S. Supreme Court Justice Lewis F. Powell, Jr. Manny was a night magistrate in Frederick and joined his Uncle Leo in the practice of law. Manny's son, David graduated from the University of Maryland School of Law and, in the late 1950s, joined his father to form Weinberg and Weinberg. Seymour Stern started his practice of law in Frederick with Weinberg and Weinberg. In the 1970s Weinberg, Michel, and Stern was formed. Allen Winik and Lawrence Finegan worked as associates with this firm.

Rand Weinberg became the fourth generation of Weinbergs to practice law in Frederick. After graduating from Washington and Lee's law school, Rand clerked for Federal Judge Edward S. Northrop and, from 1984 to 2012, was the sole owner of Weinberg and Weinberg. Later, Scott Miller joined as a partner before becoming Of Counsel for the Thompson Company in 2012. Rand also owned a title company for many years and primarily practiced real estate law. He is still associated with Miles and Stockbridge. Rand's son, Cody, is now the fifth generation of Weinbergs practicing law in Frederick. After working at Miles, he now is associated with McNees Wallace & Nurick LLC and primarily practices finance, business, and real estate law.

Not many communities can take claim to five generations of lawyers from the same family.
