Benjamin J. Cardin Distinguished Service Award Winner

On November 16, 2023, **Joanna Armentrout Shapiro** was honored with the **Benjamin J. Cardin Distinguished Service award** by the Maryland Legal Services Corporation. Joanna was nominated locally and a group of local lawyers traveled to historic Westminster Hall in Baltimore to watch Joanna receive her award. The Benjamin J. Cardin award is given to an outstanding public interest lawyer whose career has been dedicated to providing, promoting or managing civil legal services to low-income Marylanders. Past recipients from Frederick County are Nina Shore in 2019 and Blaine Hoffmann in 2016.

Joanna, assisted by Dave Pantzer, created the Maryland Custody and Divorce Client Notebook - an organizational device for litigants to use, ideally with the help of an attorney (or attorneys) from a selfhelp center, a legal help organization, or a private law firm. The Notebook also provides a step-by-step guide to court procedure so the litigant can help their lawyer and keep costs down. Joanna worked tirelessly developing and running the Frederick County Family Law Self Help Center. She met regularly with litigants, giving them tasks to complete while helping them find a lo-bono or limited scope lawyer. She worked with local lawyers to try to do some of the heavy lifting of discovery and issue development with litigants. The Notebook was developed to keep litigants organized. If a litigant proved unable to secure representation, Joanna prepared litigants to present their own case to the Court. The entire process empowered litigants and helped them control their cases. Other Self Help centers were trained on and began using the Notebook system, which developed into a physical case management tool that helps attorneys and clients work together to narrow the issues in a case, helps the client to record facts and gather information, and helps an attorney deliver limited scope service within a standardized framework.

When the pandemic shut down the courthouse, Joanna shifted seamlessly to a virtual clinic, "meeting" with litigants over zoom or similar platforms. Just since the pandemic, Joanna and her assistant, Eva Street, handled 21,000 text messages, and 17,000 zoom calls just between the two of them, providing invaluable advice and assistance to those who would otherwise not be assisted. Joanna did the work of several attorneys throughout her tenure at the Family Self Help Center.

Civics and Law Academy

93 youth from across Maryland traveled to attend this year's Civics and Law Academy held on November 11, 2023 at Frederick High School. Students attended not only from all 10 Frederick County High Schools, but also Carroll, St. Mary's, Prince George's, Carroll, Charles, Howard and Washington Counties. As in prior years, there was a Civics track and a Mock Trial track. The Civics/Law sessions included Chelsea Kadish's Issues of Speech; Unplugged- Legal issues surround internet use presented by Teresa Bean; Criminal Law Practice & Processes, an interactive and session with ASA Michael Moore, Frederick Chief of Police Jason Lando and former OPD Alex Hutt where students learned real life lessons; and Careers in law learning about alternative legal paths with FCPS' Michelle Dauksha, Hood's Maura Page, P&P Lisa Wilson and David Brooks, MA-LCADC.



Mock Trial sessions included: Bookending your Case - Opening Statement led by attorneys Detric Kemp and Devin Luqman; Bookending your Case - Closing Statement with attorneys Ian Bartman and Paul Flynn; the Art of the Cross Examination presented by lawyers Trevor Addie-Carter and Jacob Craven; and Constructing Direct Examination with counsel Richard Winters and Will Sasse. This event is co-sponsored annually by Frederick County Public Schools and the Bar Association of Frederick County. The event was planned by Colleen Bernard, EdD, Secondary Social Studies Curriculum Specialist, Magistrate Joanie Raymond Brubaker, Judge Theresa M. Adams, Michelle Dauksha, Ian Bartman, and Teresa Bean. Presenters and planners donated hours of time planning for and participating in the sessions to benefit mock trial students sharpening their skills and students who want to learn more about the law and becoming more involved in civics, government and law.
