Intra Office Emails: A cautionary note for lawyers to consider

We all know email is the easiest, quickest and cheapest way to communicate. It does however present several issues that are worthy of a refresher for all attorneys.

Amongst those issues are the following: security, rapidity and intra-office use. These challenges can in most instances be easily overcome. As for security, one cautions the client in a Retainer Agreement as to the potential issues with using email but notes that the benefits far outweigh the detriments and almost all clients opt to be able to communicate via email.

As for what I call rapidity, there is a terrible temptation to respond immediately to email from opposing counsel or clients. That is generally not the best approach, because a rapid response will not necessarily include all options and may be inappropriate in tone. The suggestion is to draft a response, send it to yourself and let it sit for 24 hours. There is no timetable on responding to email so long as the response is sent in a 'reasonable' time. Two or three days is certainly reasonable.

Lastly is intra office email where there is a great tendency to let one's hair down and be candid saying things 'privately' that one would never say publicly. This is NOT a good idea. Anything committed to writing (and that includes email) may be subject to a discovery request and may end up being produced. If what is being written would be inappropriate for sharing with a religious leader or a parent, one ought not to write it. Candid assessments can be provided to those you trust, orally.
